Texas House Redistricting Committee to hold Public Input Hearings in Collin County and the Mid-Cities *January 21 and 22.*

The Texas House Redistricting Committee is charged with conducting public input hearings as a first step to the redistricting process that will finish in 2021. Hearings will be held in Collin County and the Mid-Cities on January 21, and 22, and citizens are invited to participate.


The hearings serve an opportunity for citizens to influence the future state legislative and federal election maps. Speaking up about your community is critical to ensuring district lines are drawn to keep your community whole and grouped with similar communities that have shared interests. This ensures that your voice, and the voice of your community, is heard by your elected leaders in such decisions as the quality of the air you breathe, the quality of your child's school, and how much you pay in taxes. The hearings are also an opportunity for the public to encourage the committee to conduct a fair process open to public view and comment. Despite representations made, the public input hearings have not been well publicized – so it's critical to get the word out. These public input hearings may be one of the only opportunities ordinary citizens have to provide in-person, direct comments to the Committee about how districts should be drawn.


Grace Chimene, President of the League of Women Voters of Texas:

Voter Service Report

Voting is important. But you can't vote in Texas unless you are registered to vote at least 30 days prior to the election. There will be 3 elections this year: the March Primaries, the May local elections, and the November General Election. There may also be run-off elections for the March and May elections.

- Have you moved? If so, you must register to vote at your new address.
- Know someone who needs to register?

Become a Volunteer Deputy Registrar (VDR) and you can register other people to vote. In both Collin and Dallas Counties, VDR certification expires on December 31 of even-numbered years. Then you have to retest to be re-certified.

We ask that you help spread the word to others in your organization who would like to become a volunteer deputy registrar.

How the 2020 Census will invite everyone to respond



Every household will have the option of responding online, by mail, or by phone.

Nearly every household will receive an invitation to participate in the 2020 Census from either a postal worker or a census worker.

 **95%** of households will receive their census invitation in the mail.



 **Almost 5%** of households will receive their census invitation when a census taker drops it off. In these areas, the majority of households may not receive mail at their home's physical location (like households that use PO boxes or areas recently affected by natural disasters).

 **Less than 1%** of households will be counted in person by a census taker, instead of being invited to respond on their own. We do this in very remote areas like parts of northern Maine, remote Alaska, and in select American Indian areas that ask to be counted in person.

Note: We have special procedures to count people who don't live in households, such as students living in university housing or people experiencing homelessness.

What to Expect in the Mail

When it's time to respond, most households will receive an invitation in the mail.

Every household will have the option of responding online, by mail, or by phone.

Depending on how likely your area is to respond online, you'll receive either an invitation encouraging you to respond online or an invitation along with a paper questionnaire.

Letter Invitation

- Most areas of the country are likely to respond online, so most households will receive a letter asking you to go online to complete the census questionnaire.
- We plan on working with the U.S. Postal Service to stagger the delivery of these invitations over several days. This way we can spread out the number of users responding online, and we'll be able to serve you better if you need help over the phone.

Letter Invitation and Paper Questionnaire

- Areas that are less likely to respond online will receive a paper questionnaire along with their invitation. The invitation will also include information about how to respond online or by phone.

WHAT WE WILL SEND IN THE MAIL	
On or between	You'll receive:
March 12-20	An invitation to respond online to the 2020 Census. (Some households will also receive paper questionnaires.)
March 16-24	A reminder letter.
	If you haven't responded yet:
March 26-April 3	A reminder postcard.
April 8-16	A reminder letter and paper questionnaire.
April 20-27	A final reminder postcard before we follow up in person.

We understand you might miss our initial letter in the mail.

- Every household that hasn't already responded will receive reminders and will eventually receive a paper questionnaire.
- It doesn't matter which initial invitation you get or how you get it—we will follow up in person with all households that don't respond.

CHIP | Children's Medicaid

November was a busy month with the following events:

On Nov. 9 at Lake Highlands Jr. High Health and Safety Fair, 18 families received information. The Community Council of Greater Dallas (CCGD) provided 3 specialists to assist. All families were asked to follow up with several options available for on-line help with forms.

On Nov. 12 at the Summer Glen Apartments (arranged by Wallace Elementary) "town hall meeting," I gave an oral presentation to 75 parents with the help of the assistant principal for translation. Four families were referred to Network or other sites.

On Nov. 16 at our St. B. application help session, 8 families attended and were referred to Network for additional help because the Texas Benefit web site was undergoing maintenance. Susan Majors and Gail Johnson assisted Oscar Mojica, the CCGD specialist.

On Nov. 21 at Hamilton Park Pacesetter Magnet CHIPS and Salsa Night, their counselor arranged for a translation of an oral presentation to 14 parents. Three families were eligible for insurance and having difficulty getting signed up. I encouraged them to follow up with any of several resources, including Network.

On Nov. 21 at Thurgood Marshall Family Night, 23 parents received information. Three of these were encouraged to follow up with Network or other sources. Many families had insurance, but parents did not, and other information about clinics and Parkland Financial services were available for follow-up. The Dec. 3 event at Wallace Elementary School was cancelled.

Events are scheduled for Jan. 14th at Wallace Elementary and Jan. 18 at St. Barnabas.



Issues:

The "public charge" rule change has a chilling effect on using benefits. The Dallas Morning News feature on Oct. 31 "Texas Kids Lack Coverage" gives a summary and states that **Dallas County is one of the spots with the most uninsured children in the U.S.A.** There has been a steady decrease in funding for outreach for nonprofits. To help mitigate this trend, we are planning a training session at St. B. for on-line application help, probably early 2020 (it may be delayed due to our trainers from Network being busy with tornado victims).

We have invited LWV-Collin County, LWV-Dallas County, and the Health Department of RISD (nurses) to train with us. We will invite St. Luke's Lutheran Church to train with us for on-line insurance applications.
